Be it remembered that a Regular Meeting of the Legislative Body for the County of Hardeman, State of Tennessee was conducted in the Hardeman County Courthouse in the City of Bolivar, on the 15th day of April, 2025 at 7:00 p.m. Hon. Todd Pulse, County Mayor, was present and presiding, and a quorum of Commissioners, namely, Hon. Cory Bufford, Hon. Russell Deberry, Hon. Michion Gatlin, Hon. Mark Gilliam, Hon. Brad Grantham, Hon. Bobby Hensley, Hon. Joe Jenkins, Hon. Chandra Y. Lake, Hon. Johnny Lanier, Hon. Bethany Miller, Hon. Johnny Weems, Hon. Jackie Sain, Hon. John Vickers, and Hon. Bobby Wright were present. Hon. David Bell and Hon. Jeff Kennamore were absent. EMA – EMA DIRECTOR DON TAYLOR & ASST DIRECTOR DARREN GRANTHAM

Director Don gave the Commission an update on the recent storm and damages. There were 172 structures that were damaged. Seventeen buildings were completely destroyed, 25 structures had major damage, 50 structures had minor damage, and 80 structures were affected by the storm.

There must be a total of \$125,184.64 to be considered complete disaster. The state must reach 19 million in damages before being considered for emergency funds. West Tennessee has turned in 26 million in damages. Hardeman County has 2.8 million worth of damages currently.

A lot of overtime was worked during this crisis. FEMA will reimburse the county for the overtime and gas for what was used for that time period.

BEA – DIRECTOR TONY KIRK

Director Kirk stated that on April 2, 2025, at 5 p.m., 4,400 customers were without electricity. Restoration began on April 3rd, and total restoration was done by April 7th. There were 80 poles down and 21 transformers were replaced.

TSU EXTENSION NEW HIRE - GARY RODGERS

Mr. Rodgers introduced the new hire for the TSU Extension, Rachel Howell.

REGONITION OF TOP 10 OF BCHS & MHS – MAYOR TODD PULSE

Hon. Mayor Pulse presented awards to the top 10 students from BCHS & MHS.

B.O.E – SUPERINTENDENT CHRISTY SMITH

Superintendent Christy informed the Commission that Grand Junction school suffered no damages. The only thing they had to do was to throw away the food that had gone bad in the refrigerator.

There were also two budget amendments that Superintendent Smith brought before the Commission. The first was a budget amendment for instructional supplies for BMS and BES. This amount will be reimbursed through a grant. The second was for the purchase of school transportation (3 buses). Hon. Johnny Lanier made a motion to accept the budget amendments. Hon. Johnny Weems seconded the motion.
