# COUNTY MAYOR – FINANCIAL UPDATE, BOARD APPOINTMENTS, BUDGET AMENDMENTS

Mayor, Jimmy Sain presented eight (8) budget amendments: (1) Trustee's Commission debit from Fund Balance (39000) and credit to Trustee's Commission (82310-510) in the amount of \$1,861.43 for line being over budget; (2) Miscellaneous debit from Other Charges (58900-599) and credit to Trustee's Commission(58900-599) in the amount of \$3,782.27 for line being over budget; (3) Employee Benefits debit from Fund Balance (39000) and credit to Employee And Dependent Insurance (58600-205) in the amount of \$3,743.38 for line over budget due to end of the year HRA payments; (4) Sanitation Education/Information debit from Employee And Dependent Insurance (55720-205) and credit to Other Charges (55720-599) in the amount of \$2,002.43; (5) County Coroner/Medical Examiner debit from Fund Balance (39000) and credit to Other Contracted Services (54610-399) in the amount of \$6,240.00 for this should be the last of the FY 2020-2021 autopsies; (6) County Clerk's Office debit from Fund Balance (39000) and credit to Other Supplies and Materials (52500-499) in the amount of \$223.99 for Fund Balance will be reimbursed by restricted account (34515) at the end of the Fiscal Year; (7) County Attorney debit from Fund Balance (39000) and credit to Legal Services (51400-331) in the amount of \$49,914.75 for this should be the last of the FY 2020-2021 attorney fees; (8) Other Emergency Management (911 Dispatch) debit from Contracts with Government Agencies (54490-309) and credit to Dispatchers/Radio Operators in the amount of \$68,000.00 for dispatch will be moving to the City 911 Office at the end of August, 2021. We are moving \$68,000.00 of the contracted price to cover two (2) months of expenses.

Hon. Johnny Lanier made a motion and Hon. Gary Barber seconded to approve said budget amendments.

### ON ROLL CALL VOTE 12 VOTED AYE, 0 VOTED NAY

Mayor, Jimmy Sain presented three (3) recommendations by the American Rescue Plan Committee to buy a digital message board signage (AgriCenter, EMS, Arts Center) in the amount of \$90,000.00, pay the Courthouse HVAC bill in the amount of \$700,000.00, give the County Fire/Rescue Departments (11 Departments \$25,000.00 each).

Also, it was recommended to pay off the debt on the EMS Center from the Tennessee State Appropriations in the amount of \$506,075.20.

Hon. Bobby Wright made a motion and Hon. Russell Deberry seconded to approve these four (4) recommendations.

## ON ROLL CALL VOTE 12 VOTED AYE, 0 VOTED NAY

Mayor, Jimmy Sain recommended that in regards to the CCA/Hardeman County Contract, the County should dissolve the HCCFC and the HCCFC-2. The Contract with Tennessee will be administered through the Trustee's Office and the Administrative Fee will be paid to the General Fund. Hon. Chris Bell made a motion and Hon. Johnny Weems seconded to approve said recommendation.
