Be it remembered that a Regular Meeting of the Legislative Body for the County of Hardeman, State of Tennessee was conducted in the Hardeman County Courthouse in the City of Bolivar, on the 18th day of March, 2025 at 7:00 p.m. Hon. Todd Pulse, County Mayor, was present and presiding, and a quorum of Commissioners, namely, Hon. David Bell, Hon. Cory Bufford, Hon. Russell Deberry, Hon. Michion Gatlin, Hon. Mark Gilliam, Hon. Brad Grantham, Hon. Bobby Hensley, Hon. Joe Jenkins, Hon. Jeff Kennamore, Hon. Chandra Y. Lake, Hon. Johnny Lanier, Hon. Bethany Miller, Hon. Johnny Weems, Hon. Jackie Sain, Hon. John Vickers, and Hon. Bobby Wright were present. County Clerk, Tonet Griggs and County Attorney, Dale Conder Jr. was present and the meeting was opened in due form of the law and had to wit:

SHERIFF DEPARTMENT - SHERIFF DOOLEN

Sheriff Doolen stated that they need to remove three vehicles from inventory to surplus. (SEE ATTACHED)

The work truck is down and they are unable to do trash pickup at the moment. The work truck may possibly have to be replaced.

LAW ENFORCEMENT COMMITTEE – COMMISSIONER BUFFORD

Hon. Cory Bufford said that there are three things he wants to speak on. The first thing is to address the parking lot issue. There are cracks that are three inches wide and about forty feet long that need to be fixed.

There is also an issue of salary. Hardeman County starting salary is \$46,000. Figures were given for uncertified \$25 per hour, and certified officer \$27-\$30 per hour.

Thirdly Cheri Baker is finishing her CCFO certification and they are giving her an increase. These funds will come from the sheriff department's reserve fund.

The Sheriff's Department has 25 jailers and 17 officers. There are 28 HVAC units on top of the CJC, we replaced 8 units and 20 units are currently not working properly.

The sheriff's department has three new Chevy Tahoes. They need to have stripes and lights put on before they can be put on the road.

The Law enforcement committee is trying to find a non-lethal way to catch strays.

We received new carpet for free from Madison County and they have enough to do the Trustee's office.

BEER BOARD - COMMISSIONER CHANDRA LAKE

Hon. Chandra Lake said the Board met on March 13th and will meet again in two weeks to talk about compliance.

HIGHWAY DEPARTMENT - SUPERINTENDENT CASEY SWIFT

Superintendent Casey said that they have some more things to move from inventory to surplus. Hon. Russell Deberry made a motion to accept the additional surplus and Hon. Michion Gatlin seconded the motion.

CARRIED BY ACCLAMATION

TDOT project is about nine miles of resurfacing from Walton Road to Davis Way. Milling stockpile can be sold to anyone.

Hon. Michion Gatlin mentioned needing a sign on warning of curve ahead on Vildo Road. He stated there was a concern from citizens because there have been a few accidents there.

EMA ASSISTANT DIRECTOR DARREN GRANTHAM

Assistant Director Grantham said all leaders need to participate and take the one-hour training. If a disaster should happen and FEMA offers a grant, they will look at all the leader's "commissioners" to see if they have had the training required. If one out of the 16 has not completed the training course, this will knock out our county for eligibility.

ZONING – DIRECTOR RON PIRTLE

Director Ron said that the meeting has been postponed and moved so that they will be in compliance with the 16-day notice. The notice will be posted on the county website as well as the billboard in the courthouse.
