BOARD OF EDUCATION, SUPERINTENDENT WARNER ROSS

Superintendent, Bobby Doyle presented seven (7) budget amendments for the Hardeman County Board of Education.

Hon. Johnny Lanier made a motion and Hon. Mark Gilliam seconded to approve said budget amendments.

HIGHWAY DEPARTMENT - SUPERINTENDENT CASEY SWIFT

Superintendent, Casey Swift presented a budget amendment debiting Wheel Tax (131-40240) and crediting Fund Balance (131-39000) in the amount of \$6,400.00 to increase the wheel tax revenue and to correct the five (5) year average.

Mayor, Jimmy Sain presented a Resolution to amend the Zoning Resolution of Hardeman County, Tennessee: To delete Planned Recreation Residential Development District Provisions.

Mayor, Jimmy Sain also presented a Resolution Amending the Official Zoning Map of Hardeman County, Tennessee, to Rezone Tax Parcel 007.03, Hardeman County 118, owned by Wayne County Bank from PRRD (Planned Recreational Residential Development) to FAR (Forestry/Agriculture/Residential).

COUNTY MAYOR – FINANCIAL UPDATE, BOARD APPOINTMENTS, BUDGET AMENDMENTS

Mr. Pat Harcort from A2H Engineering gave an update on the landfill.

Mayor, Jimmy Sain requested nominations for Chairman of the Hardeman County Commission.

Hon. John Vickers made a motion and Hon. Russell Deberry seconded to nominate Mayor, Jimmy Sain as Chairman.

Hon. Bobby Wright made a motion and Hon. Justin Howell seconded to nominate Hon. Elvis White as Chairman.

ON ROLE CALL VOTE 2 VOTED WHITE, 10 VOTED SAIN – WHITE PASS

Mayor, Jimmy Sain requested nominations for Vice Chairman of the Hardeman County Commission.

Hon. Chris Bell made a motion and Hon. Russell Deberry seconded to nominate Hon. Johnny Lanier as Vice Chairman.

Hon. Elvis White made a motion and Hon. Bobby Wright seconded to nominate Hon. Justin Howell as Vice Chairman.

ON ROLE CALL VOTE 10 VOTED LANIER, 3 VOTED HOWELL

Mayor, Jimmy Sain presented a Statement of Expenditures for Hardeman County.

Mayor, Jimmy Sain presented a budget amendment for the Hardeman County Sheriff's Department debit from Fund Balance (39000) in the amount of \$23,894.00, credit to Secretaries (54110-161) in the amount of \$16,000.00, credit to Insurance (54110-205) in the amount of \$5,120.00, credit to Retirement (54110-204) in the amount of \$1,550.00, credit to Social Security (54110-201) in

the amount of \$992.00 and credit to Medicare (54110-212) in the amount of \$232.00.

Hon. John Vickers made a motion and Hon. Gary Barber seconded to approve this budget amendment.

ON ROLE CALL VOTE 13 VOTED AYE, 0 VOTED NAY

Mayor, Jimmy Sain explained that the City of Bolivar would pay for half of the costs to get a digital copier for the Bolivar/Hardeman County Library and that those fees would come from the COVID-19 Funds.

Hon. Elvis White made a motion and Hon. Johnny Weems seconded to approve said request.

ON ROLE CALL VOTE 13 VOTED AYE, 0 VOTED NAY

Mayor, Jimmy Sain went over the EMS Report and West TN Health Care. After City Mayor, Julian McTizic and some employees of the Hardeman County EMS spoke, no further action was made.
