BOARD OF EDUCATION, SUPERINTENDENT WARNER ROSS

Hon. Bobby Doyle presented to the Commission two (2) budget amendments; (1) debit from Unassigned Fund Balance (141-39000) and credit to Regular Capital Outlay (141-76100-706-MHS) in the amount of \$17,000 to pay the remaining costs on MHS gym out of the GP fund account; (2) debit from Unassigned Fund Balance (141-39000) and credit to Maintenance and repair Buildings (141-72620-335) in the amount of \$75,000 for the insurance money for the damaged gym floor at TES came in before June 30, 2019; however, the contractor was unable to get the job completed until late summer which Hon. Buzz Bar and trucks which Hon. Mark Gilliam made a motion and Hon. Elvis White seconded to approve.

Mayor, Jimmy Sain also presented a budget amendment for Sheriff Dept. debit from Fund Balance (39000) and credit to Other Charges (54110-599) in the amount of \$102,000 for the Sheriff was awarded that money from the lawsuit versus the County. Hon. Chris Bell made a motion and Hon. Bobby Wright seconded to approve said budget amendment.
