There were two candidates for the General Session Judge, Harriet Thompson and Rickey Griggs. Hon. Brad Grantham made the motion to nominate Harriet as a candidate for General Session Judge and Hon. David Bell seconded the motion. Hon. Chandra Lake made a motion to nominate Rickey Griggs as a candidate for General Session Judge and Hon. Johnny Weems seconded the motion.

Harriet Thompson was voted in with a 10 to 6 vote.

# ZONING RESOLUTION PRESENTATION - ANDY SHELTON

Andy Shelton went over the reasoning of the resolutions to be presented based on Southwest Tennessee Development District (SEE ATTACHED). Jonathan Fleming, John Cooper, and Morey Hill also spoke on the restrictions and monetary setback. Jonathan said that with the 500 feet privacy setback they will be looking at having to use more acreage than originally deemed needed. Jon Cooper expressed his concerns of being grandfathered in and now there are new regulations/restrictions. Morey said that they have looked at helping with soil fertility and having sheep to fertilize and keep grass down. He was asked if the 500 feet setback or the 6 inch waterline was the bigger concern, Morey said that would be a hard choice because having to put so much money into being able to

have city water is a huge upfront expense and also having to setback for privacy 500 feet would be asking for more land to work with.

## **RESOLUTIONS:**

There were two set of options on the first part of the two-option Resolution Presentation. Resolution 2-24-01 had a Roll Call Vote 7 AYE 9 NAY and did not pass the first vote but after a consideration. Hon. Chandra Lake made a motion to change her vote of no to yes and Hon. Mamie Polk seconded the motion. After further explanation from the Zoning Committee and a citizen, Hon. Johnny Weems made a motion to revote on Resolution 2-24-01 and Hon. Bobby Wright seconded the motion. They took a roll call vote to reconsider the vote with Roll Call Vote 14 AYE 2 NAY.

Resolution 2-24-01 (Revote): With this Resolution passed the County Commission moved into the next resolution which would be option 2.
