## BOARD OF EDUCATION, SUPERINTENDENT BOBBY DOYLE

Superintendent Bobby Doyle presented one budget amendment for Board of Education debiting \$6,700.00 from Unassigned Fund Balance (141-39000) and credit to Administration Equipment (141-72510-701) in the amount of \$5,000.00, credit to Data Processing Services (141-72510-317) in the amount of \$200.00 and credit to Data Processing Supplies (141-72510-411) in the amount of \$1,500.00 because of COVID the fical services/HR/Benefits Adm assistant director has determined that the departments need the ability to work remotely. These numbers represent the cost to do so. We currently have two computers that we might be able to use. The \$5,000.00 represents the cost of three new laptops.
